
STANDARD PHOTOSHOOT AGREEMENT

Thank you for choosing Rosemary Hill for your photoshoot.

This Agreement applies to standard outdoor lifestyle photography, including family, couple, engagement, maternity, newborn, matric farewell and similar non-commercial photoshoots.

Booking Process

1. All photographers are required to attend a once-off guided site visit of Rosemary Hill before conducting a photoshoot. Site visits must be booked through www.activitybridge.com and takes approximately one hour.
2. During the site visit, photographers will be required to drive their own vehicle to become familiar with the farm roads, approved shoot locations and access routes.
3. The site visit and signing of this Agreement only needs to be completed once. Rosemary Hill will keep the signed Agreement on file for future bookings.
4. All standard photoshoots must be booked online through Rosemary Hill's booking platform and are subject to availability. A booking is only confirmed once the online booking process has been completed and full payment has been received.
5. Should you need to postpone your booking, all monies paid may be transferred to a future date, subject to availability.
6. On the day of the shoot, all photographers and clients must report to the Welcome Centre to receive their access bands.

Standard Photoshoot Fee

R720 per photographer for one family of five or one couple.

Where more than one couple or family is photographed during the same booking, an additional R720 will be charged per couple or per family.

Standard photoshoots are limited to 1–2 hours and must take place between 06:00 and 18:00 on weekends and from 07:00 and 18:00 on weekdays.

Conditions of Use

- The standard photoshoot fee includes the use of approved outdoor areas only, including gardens, lawns, fields, trees and the exterior of buildings, as identified during the site visit.
- Should you wish to use an accommodation unit for your photoshoot, the unit must be booked as a standard overnight stay. Bookings can conveniently be made through our website: <https://rosemaryhill.co.za/all-accommodation/>
- Photoshoots are not permitted on days where weddings or private events are taking place, as those clients have exclusive use of the facilities.
- Confetti, smoke bombs, colour powder, fireworks, open flames or similar materials are not permitted unless approved in writing by Rosemary Hill.
- Drone usage requires prior written approval from Rosemary Hill and must comply with all applicable legislation.
- Please adhere to your allocated booking time. Additional time may be subject to availability and additional charges.

STANDARD PHOTOSHOOT AGREEMENT

- Please do not block roads, pathways or trails. Right of way must always be given to farm vehicles, hikers, livestock, bicycles, golf carts and staff vehicles.
- Please respect the farm and do not damage or disturb plants, gardens, landscaping, buildings or any Rosemary Hill property.
- Please do not move any of our furniture in the venues: Maze and Chapel.
- All props, equipment and rubbish brought onto the farm must be removed before leaving.
- Rosemary Hill is a working farm. Entry onto the property is entirely at your own risk. Rosemary Hill shall not be liable for any loss, theft, damage, injury or death arising from the use of the property.
- The photographer shall be responsible for any damage caused by themselves or any person attending the photoshoot.
- Entry and use of the facilities are at your own risk. Rosemary Hill will not be liable for any loss, damage, injury or death whatsoever incurred while using the premises, or as a result of using the premises.
